## GENERAL USE GUIDE

This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended.

### Golf Course Greens and Tees

Apply 0.5 to 2.0 fl oz per 1000 sq ft in enough water to provide sufficient foliar coverage.

Repeat application every 7 to 14 days.

Warm season turf may require more frequent applications to achieve desired results.

### Fairways Sports Turf Lawns

Apply 1.0 to 3.0 fl oz per 1000 sq ft in enough water to provide sufficient foliar coverage.

Repeat application every 14 to 28 days during the growing season.
