## GENERAL USE GUIDE

This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended. Shake well.

<b>Golf Course Greens, Tees, and Fairways</b>	Apply 1.0 to 3.0 fl oz per 1,000 sq ft. Repeat application every 7 to 21 days depending on growth and color. For new establishment apply more often. For recovery increase rate to 3.0 to 5.0 fl oz per 1,000 sq ft.
<b>Sports Turf Residential and Commercial Lawns</b>	Apply 1.0 to 3.0 fl oz per 1,000 sq ft. Repeat application every 4 to 6 weeks.
<b>Trees, Ornamentals, and Flowers</b>	<b>Foliar Spray:</b> Mix 24 to 36 fl oz in 100 gal of water. Spray to the point of runoff. <b>Soil Applications:</b> <b>TREES AND SHRUBS-</b> Add 2.0 to 3.0 fl oz per caliper inch into 2 gal of water and drench into root zone. <b>FLOWERS AND SMALL PLANTS-</b> Add 0.5 to 1.0 fl oz per gal of water. Thoroughly drench soil around area.

**CAUTION:** The application of fertilizing materials containing Molybdenum (Mo) may result in forage crops containing levels of Molybdenum (Mo) which are toxic to ruminant animals.
