FIRST AID

GENERAL USE GUIDE

Use one tablet in hose end applicator for direct surface application. May be used as part of a comprehensive water management program. Apply to correct localized dry spots, or use to syringe greens and tees during extreme weather conditions.

Stress Reliever Tabs Plus will not burn turfgrass and does not need to be watered in. One treatment will last 3 to 4 weeks depending on local soil and weather conditions. Applications made on a more frequent schedule will not adversely effect soil conditions and turfgrass.

Store in original container. Exposure to high heat and humidity for prolonged period of time may cause tablets to melt. Wear appropriate personal protective gear when applying product. For people with sensitive skin, prolonged contact may cause skin irritation. Dispose of containers and unused product in accordance with local, state, and federal regulations.
