# DIVERSION

## DIRECTIONS FOR USE

Diversion is a multi-purpose surfactant, containing a water conditioner. Diversion significantly reduces the surface tension of water and improves the infiltration of rainfall and irrigation. Always mix and apply Diversion in accordance with label instructions.

<b>Injection</b>	Apply 20 to 40 fl oz (591 mL) of Diversion into water volume sufficient to treat one acre (.40 ha) of turfgrass.
<b>Spray Application</b>	Apply 20 to 40 fl oz (591 mL) of Diversion in a minimum of 60 gallons (227 L) of water to treat one acre (.40 ha) of turfgrass.
<b>Application Interval</b>	Use Diversion monthly throughout the growing season. The application interval may be adjusted as needed.
