Cool Season Turf (Zones 1–6)	Apply two applications of 8 fl oz each in 1 to 2 gallons of water per 1,000 sq ft at a 30 day interval to relieve the symptoms of LDS for 4 to 6 months. Apply 4 to 6 fl oz in 1 to 2 gallons of water per 1,000 sq ft every 30 days, if shorter application intervals are desired.
Cool or Warm Season Turf (Zones 1–10)	Apply 4 to 8 fl oz in 1 to 2 gallons of water per 1,000 sq ft every 30 to 60 days.
