Terms and Conditions:

- 1. A product qualifies when the minimum quantity of that brand is purchased between October 1, 2023 and May 31, 2024.
- Any rebates submitted and verified by July 31, 2024 will be paid by September 2024. Any rebates submitted by after June 30, 2024, will not be accepted.
