Not valid for distributors, dealers, aquatic applicators, or any other resale entity. Eligible Early Order Program purchases must be invoiced between October 1, 2026 and December 11, 2026. Rebate Lock applies only to qualifying in-season purchases made between January 1, 2027 and September 30, 2027. Rebates will be issued based on sales reported to SEPRO by authorized agents/distributors within applicable program dates. Pinnacle offer may not be combined with any other special offers, rebates, or discount programs unless otherwise stated. For pesticides sold into the state of California or Washington, the agent/distributor is instructed to add the California Mill Tax Assessment or Washington Hazardous Substance Tax Assessment to the customer's purchase price. SEPRO will add these assessments to the agent/distributor invoice at the applicable tax rate. SEPRO reserves the right to cancel or modify this program at any time. Rebates will be paid as an account credit to the selling agent/distributor or as a check made payable to the purchasing business. Purchases must be paid in full to receive a rebate. Pinnacle EOP rebates will be issued by August 31, 2027. In-season program rebates, including eligible Rebate Lock purchases, will be paid by December 31, 2027. Rebate Lock purchases do not apply toward future discount or promotional programs. Account credit with selling agent must be used within 12 months or funds will be forfeited and returned to the manufacturer.
