#### **GENERAL USE GUIDE**

FOR USE ON GOLF COURSES, ATHLETIC FIELDS, COMMERCIAL, MUNICIPAL OR RESIDENTIAL PROPERTIES.

For best results, apply SYNTRYX to dry plants and avoid application conditions that favor drift. To minimize staining risk, wet concrete and masonry surfaces with water prior to application and rinse with water immediately after application. Shake well before using

PERSONAL PROTECTIVE EQUIPMENT (PPE): Applicators or other handlers of this product must wear: long-sleeved shirt, pants, socks, shoes, chemical-resistant gloves, and protective eye wear. Consult the MSDS for further information.











Apply 48 to 64 ounces of SYNTRYX in 50 gallons of spray solution per acre.

Spray volume, nozzle selection, turf type or condition may affect the color intensity of the application. Adjust the use rate to achieve desired results.

#### MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed.
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants.
- Dry soluble and suspension fertilizers / micronutrients. 3.
- Liquid drift retardants and flowable formulations (F & FL) (SYNTRYX). 4.
- 5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME).
- 6. Emulsifiable concentrates (E, EL or EC).
- 7. Solutions and soluble liquids (S or SL).
- Liquid micronutrients and fertilizers.
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS).
- Finish filling to desired spray volume level and continue agitation.

STORAGE AND DISPOSAL: May be stored below 32°F if thawed and thoroughly agitated before use. Keep container closed in storage. Do not allow water to be introduced. Store only in original container. Triple rinse when empty and offer for recycling. Always dispose of container in accordance with local, state and/or federal regulations. Do not reuse empty container.
